**DIRECTIONS to the XL Sports World Complex:**

400 North Street Saco, ME 04072

Follow Maine Turnpike to Exit 36 - Saco, ME. Go through the tollbooth and take Exit #1- Industrial Park Road. Take a left at the light onto Industrial Park Road. At the end of the road take a right onto North Street. The XL Sports World Complex will be approximately 1 mile ahead on the left.



## REGISTRATION

- Pre - registration \$55 first 3 events, \$5 each additional (before Wednesday June 26, no refunds)  
*If registration forms are not received by the date of the tournament you will need to pay at the door and we will send your check back to you when we receive it.*
- Registration \$65 first 3 events, \$5 each additional (after June 26th & at the door)
- Spectator admission \$8 (4 and under free)
- *Competitors & Spectators - cash/credit only at the door - no checks*

## TIMELINES

- Pre - registration check in: 7 - 9 a.m.
- Synchronized Kata (Followed immediately by Synchronized Weapons) begin at 8:00a.m. **Pre-Register Only!**
- Demo team competition begins at 9:00 a.m.
- Black belt meeting: 9:30 a.m.
- Official tournament kickoff: 10:00 a.m.

## RULES

- **Sparring all division** - Light head contact, NO face contact.
- **Synchronized Kata** - 2 or more competitors performing the same kata in sync.
- **Continuous Sparring (Intermediate & Up, Ages 10 and older)**  
**Adults:** Two (2) ninety (90) second rounds with a 30 second break in between rounds.  
**Juniors (17 yrs & under):** Two (2) sixty (60) second rounds with a 30 second break in between rounds. Contact and penalty rules are the same as point sparring.
- **Mandatory equipment** - Foam headgear, boots, gloves, mouth guards and groin protection required of all fighting competitors.
- **Demo teams** - will be judged on style and creativity. Teams must provide their own music. Demo performances should be between 3 and 5 minutes in length.
- **Ring assignments** - will be pre-determined. You will receive your ring assignment at check in.
- **Open Forms and Weapons** - Anything non traditional including; cartwheels, flips, aerials, flashkicks, etc. **If your weapon leaves your hand in any manner such as throwing** then it will be considered an open form.
